#### EO21/09 The LNER 2022 Timetable Consultation

This consultation was discussed, there will be a negative impact on Northallerton and the services between here and Leeds, to Manchester Airport and northbound in the commuter period to Darlington. It is also contradictory to the government's push for devolution of powers to the north. There was also discussion about the changes that will affect the Grand Central routes to and from the North East and the Dales. Cllr. Cornfoot had prepared a draft response to this and proposed that the Town Council write to the train operators and the Department of Transport, Rishi Sunak MP, NYCC and HDC.

It was resolved that Northallerton Town Council will write to the stakeholders, expressing their concerns strongly and focusing on the negative economic growth impact on the town and surrounding areas.
